



VISITOR PRE-SCREENING QUESTIONNAIRE

On December 21, 2020 the Government of Ontario announced a provincewide shutdown to slow the spread of COVID-19. Under Ontario Regulation 82/20, Schedule 2, Section 6, Crate’s is permitted to be open by-appointment only.

Before coming to Crate’s for an appointment, every visitor must complete this questionnaire

- a) **Health Questionnaire** Do you have one or more of the following symptoms?
 - fever (feeling hot to the touch, a temperature of 37.8 degrees Celsius or higher)
 - chills
 - cough that's new or worsening (continuous, more than usual)
 - barking cough, making a whistling noise when breathing (croup)
 - shortness of breath (out of breath, unable to breathe deeply)
 - sore throat
 - difficulty swallowing
 - runny, stuffy or congested nose (not related to seasonal allergies or other known causes)
 - lost sense of taste or smell
 - pink eye (conjunctivitis)
 - headache that’s unusual or long lasting
 - digestive issues (nausea/vomiting, diarrhea, stomach pain)
 - muscle aches
 - extreme tiredness that is unusual (fatigue, lack of energy)
 - falling down often

b) **Travel** Have you traveled outside Canada in the past 14 days?

c) **Exposure to COVID-19** Have you had close contact with a person diagnosed with COVID-19?

NO > If you answered “no” to **all** questions, sign below to self-certify that you are clear for your appointment.

When You Arrive

- ✓ Please park in the designated Customer Parking area, stay in your car and call 705-327-9741 to let us know you are here – we will meet you at your car with disposable face masks and gloves, if you do not have your own
- ✓ You will be directed to enter our reception area, apply alcohol-based hand sanitizer, have your temperature taken using our non-contact thermometer and sign in with our log book
- ✓ Please ensure you wear your mask and maintain 2M physical distance at all times while at Crate’s
- ✓ Please don gloves prior to boarding any vessel
- ✓ Please observe all COVID-19 signage throughout the property and follow staff directions

What You Can Expect from Us

- ✓ A maximum of 2 customers will be permitted inside Crate’s facilities at any given time - exceptions may be made for more than 2, provided all persons live in the same household
- ✓ When your temperature reading is taken at Crate’s, your photograph will be digitally recorded and date-stamped by the thermometer - this information will be stored securely for the purpose of contact tracing
- ✓ Your Crate’s representative will be wearing a face mask at all times, as well as gloves while onboard any boat
